Legal Information

Please read your permit carefully. If a date is missing in sequence it is an unavailable date. Only dates listed are confirmed dates.

This permit can be assessed for change, cancellation and late fees. Fees and dates are subject to change. Invoices that are past due by 30 days will be charged a late fee. Failure to pay within 60 days will result in the cancellation of any current permits and the inability to book any new permits.

All Centennial facilities and grounds are tobacco/drug/alcohol free.

Any damage to district-owned property must be paid in full by the group using the facility. This district assumes no liability with the use, loss or damage of a group's own equipment.

All activities must be supervised by a competent and responsible adult.

Groups are responsible for cleanup of the area they use and should leave it in an orderly condition.

No food or drinks allowed in gyms. Food or drink must be served and consumed in cafeteria or other designated area and must appear on facility use form. Must follow District Food Policy and procure necessary food license from Anoka County Health Department.

All accidents/incidents must be reported to Centennial Community Education within 24 hours at 763-792-6104. In an emergency, call 911 or the Anoka County dispatcher 763-427-1212.

When Centennial Schools are closed due to inclement weather or building emergencies, all facility use permits are cancelled. Emergency school closing line 763-792-6030.

Only equipment specified on the permit will be made available to the permit holder. It is the permit holder's responsibility to set up and leave the facility in the same condition. There will be additional charges for set up and take down for large groups or if the permit holder does not fulfill their obligations.

Soft-soled, non-marking shoes must be worn on gym floors. No regulation soccer balls, baseballs or softballs allowed - only soft indoor or Nerf-type balls.
